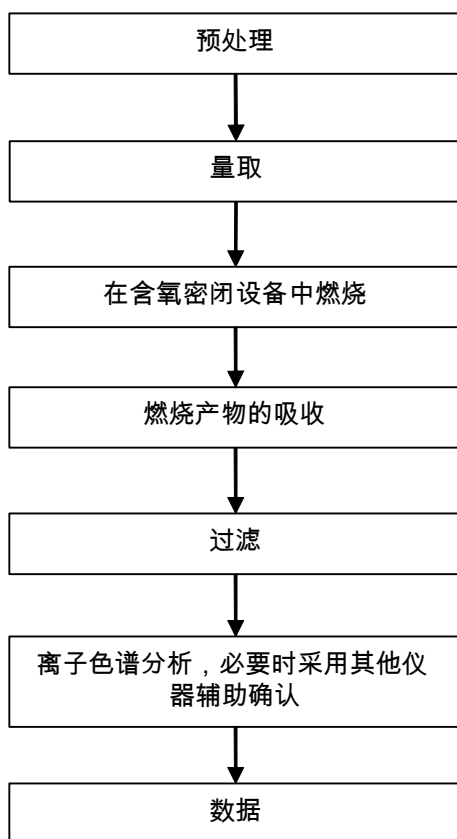

Halogen 检测流程图

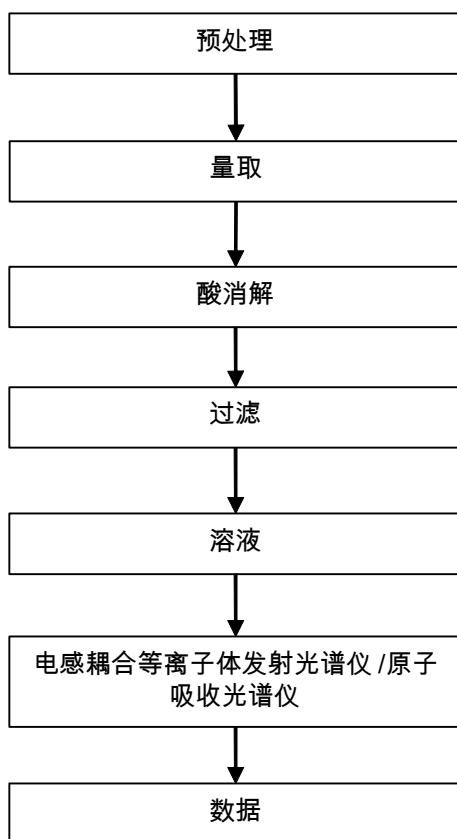
